Articles of Organization (General Laws, Chapter 180)

Federal Identification Number: 200581741

ARTICLE I

The name of the corporation is:

THE PEPPERELL HISTORICAL SOCIETY, INC.

ARTICLE II

The purpose of the corporation is to engage in the following business activities:

THE PURPOSE OF THIS SOCIETY SHALL BE TO PROMOTE THE DISCOVERY, PRESERVATION, DISSEMINATION OF THE HISTORY OF PEPPERELL FOR POSTERITY. TO THIS END, THE SOCIETY'S OBJECTIVES SHALL INCLUDE, BUT ARE NOT LIMITED TO, SERVICE TO THE COMMUNITY THROUGH EDUCATION AND COOPERATION, THE DOCUMENTATION, PROTECTION AND INTERPRETATION OF HISTORICAL RECORDS AND ARTIFACTS RELATING TO THE HISTORY OF PEPPERELL AND ITS PEOPLE; TO PRESERVE ITEMS OF CURRENT EVENTS THAT MAY HAVE HISTORICAL INTEREST IN THE FUTURE; TO INTEREST AND UNITE THE TOWNSPEOPLE IN A FINER PUBLIC SPIRIT, THROUGH A FULLER UNDERSTANDING OF THE TRADITIONS AND HISTORY, BOTH PAST AND IN THE MAKING, OF OUR TOWN AND ITS NEIGHBORING COMMUNITIES.

ARTICLE III

A corporation may have one or more classes of members. If it does, the designation of such classes, the manner of election or appointments, the duration of membership and the qualifications and rights, including voting rights, of the members of each class, may be set forth in the by-laws of the corporation or may be set forth below:

THE CLASSES OF MEMBERSHIP ARE SET FORTH IN THE SOCIETY BY-LAWS.

ARTICLE IV

Other lawful provisions, if any, for the conduct and regulation of the business and affairs of the corporation, for its voluntary dissolution, or for limiting, defining, or regulating the powers of the corporation, or of its directors or members, or of any class of members, are as follows: (If there are no provisions state "NONE")

THE SOCIETY WILL ENGAGE IN NON-PROFIT ACTIVITIES AS PERMITTED BY SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE OF THE UNITED STATES AS IT NOW EXISTS AND AS HEREAFTER AMENDED.

Note: The preceding four (4) articles are considered to be permanent and may ONLY be changed by filing appropriate Articles of Amendment.

ARTICLE V

The by-laws of the corporation have been duly adopted and the initial directors, president, treasurer and clerk or other presiding, financial or recording officers, whose names are set out on the following page, have been duly elected.

ARTICLE VI

The effective date of organization of the corporation shall be the date approved and filed by the Secretary of the Commonwealth. If a *later* effective date is desired, specify such date which shall not be more than *thirty days* after the date of filing.
